Whereas it is necessary to declare the objects and terms of the public charitable trust, being constituted under these presents .

Now this indenture witnesseth as follows:-

1. That, in order to effectuate his aforesaid desire the settlor has set Apart and handed over to the Trustees, a sum of Rs.50,000/- (Rupees Fifty thousand) only (hereinafter called the Trust Fund' which expression shall include cash and any other property or investments of anykind whatsoever into which the same or any part thereof might be converted, invested, or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents and the trustees shall hold and stand possessed of the same upon the trust objects to the power, provisions, agreements and declarations hereinafter contained.

6. Board of Trustees:-

The Trust shall be vested in a Board of Trustees (herein-after called the Board) which shall consist of not less than three and not more than seven Trustees. The first Trustees constituting the Board are:-

1. Ms. Seema
2. Shri Nitin Kumar
3. Shri Nageshwar Prasad Singh

The Board of Trustees shall have one chairman. The first Chairman of the Board will be Shri Nitin Kumar and he will continue as the Chairman of the Board during his pleasure and shall not be liable to be removed. The term of all other trustees shall be of three years.

6.1 The first Trustees constituting the Board shall have the power to increase the strength of the Board by nominate there to one or more person on the recommendation of Chairman, whether on the same occasion or on different occasions,

as trustee or trustees, but the total number of persons constituting the Board shall at no time exceed seven.

6.2 In the event of vacancy in the office of Chairman, the Board shall elect a chairman from amongst themselves.

6.3 If any of the Trustees shall die, or desire to retire, refuse or become incapacitated to act as a Trustee or take the benefit of Insolvency law, then and in every such case, there shall be a vacancy in the Board.

6.4 A trustee may be removed from office for misconduct or for obstruction of the functioning of the trust by a resolution adopted by two-third majority of the members of the Board present and voting at a meeting specially called for the purpose. The Trustee affected shall be given reasonable opportunity to show cause against the proposed action.

6.5 Vacancies in the Board may be filled by the remaining Trustees at a meeting called for the purpose. Casual vacancies in the Board
